A RESOLUTION OF THE DEER CREEK DRAINAGE BASIN AUTHORITY, A MUNICIPAL AUTHORITY SITUATE IN THE TOWNSHIP OF WEST DEER, ALLEGHENY COUNTY, PENNSYLVANIA, AUTHORIZING THE FILING OF DECLARATIONS OF RELINQUISHMENT OF EASEMENTS OF RIGHTS-OF-WAYS PREVIOUSLY CONDEMNED ACROSS THE PROPERTIES BELOW LISTED IN THE TOWNSHIP OF INDIANA.

WHEREAS, it is the intent of the Deer Creek Drainage Basin Authority (the "Authority") to construct and maintain a sanitary sewer line extension and related improvements in Indiana Township, specifically the West Deer Senior Center extension project (the "Project"); and

WHEREAS, the Commonwealth of Pennsylvania as authorized by the Municipality Authorities Act of 2001, as amended, authorizes the boards of municipal authorities to construct sanitary sewer lines; and

WHEREAS, the Commonwealth has further authorized the boards of municipal authorities to secure by condemnation and the power of eminent domain all easements and rights-of-way necessary for the construction of sanitary sewers; and

WHEREAS, PURSUANT TO THE POWERS GRANTED IT BY SECTION 5607(d)(15) of the Municipality Authorities Act of 2001, the Authority exercised its power of eminent domain over certain properties situated in the Authority's service area; and

WHEREAS, subsequent o the Authority's condemnation of the certain properties enumerated below, it was granted rights-of-way by the property owners, which provide the Authority adequate access to the properties, and the Authority's service area; and

WHEREAS, subsequent to the Authority's condemnation of the certain properties enumerated below, it was granted rights-of-way by the property owners, which provide the Authority adequate access to the properties, and the Authority's exercise of its power of eminent domain is no longer necessary for the Project.

NOW THEREFORE, be it resolved by the Board of the Deer Creek Drainage Basin Authority that pursuant to the powers vested in it by law and be it so hereby resolved that:

1. The Deer Creek Drainage Basin Authority hereby authorizes the filing of Declarations of Relinquishment with respect to easements of rights-of-way across the properties of the following named persons, and the Deer Creek Drainage Basin Authority Solicitor is hereby directed to forthwith file declarations of relinquishment to relinquish and surrender the easements across the properties of the following named persons, more particularly described in Exhibit "A" attached hereto:
