August 16, 2021

Call Meeting to Order

Reading and Approval of Minutes

Solicitor's Report

AVJSA Expansion

Mr. Brown reported no new updates on the AVJSA expansion. Bids were to be awarded earlier this month but more time was needed for right-of-way acquisitions and some condemnations. The opening bid date is now August 27, 2021 at 2 p.m. Mr. Higgins and Mrs. Biery will attend.

Pennsylvania Sunshine Act

Mr. Brown reported a change in the PA Sunshine Act. The change takes effect next month and requires all public bodies post a more detailed meeting agenda on the facilities door and website 24 hours before the meeting. The new amendment requires a listing of all items to be voted upon at that meeting. There will be an exception for emergencies. Mr. Brown offered to work with Mrs. Biery to affect this change.

Mr. Brown said the other topics he has for discussion must be held in executive session.

Executive Session

MOTION was made by Mrs. Pastura and seconded by Mr. Drischler to move the meeting into Executive Session at 7:12 p.m. to discuss personnel matters. Motion carried unanimously.

The meeting was reconvened at 7:28 p.m. where the Board discussed personnel issues.
