Reading and Approval of Minutes

Mr. Higgins asked the Board to review the minutes for the Regular Meeting on August 21, 2023.

MOTION was made by Mr. Plesh and seconded by Mr. Drischler to approve the minutes of the August 21, 2023 Regular Meeting. Motion carried unanimously.

Accountant's Report

Mr. Vancheri presented the Operating Accounts Receipts and Expenses and Funds Available and Debt Obligations reports for August 2023.

Engineer's Report

Paving Project Update

Mr. Sprung reported that A Folino Construction, Inc. has satisfactorily completed the repairs to the parking lot.

MOTION was made by Mr. Plesh and seconded by Mr. Drischler to approve the payment of \$5,000 retainage to A. Folino Construction, Inc. Motion carried unanimously.

Manhole 663 Repair

Mr. Sprung reported that the required permitting was received and the boulder at manhole 663 has been removed. Advanced Rehabilitation Technology has been asked to schedule the lining and repairs to this manhole.

Capital Improvements

As part of the Authority's comprehensive maintenance plan, Mr. Sprung reported that Mr. DeBaldo has identified additional manholes that should be added to the schedule for lining. Areas that may potentially require full replacement are at the aerial crossing at the Fawn Haven Plan and the manhole and sewer lines near the Vitale property on Short Street in Indianola.

Local Share Act Grant

Generator Repair at Rich Hill Pump Station

Mrs. Biery reported that the Rich Hill Pump Station generator was repaired by Authority personnel at a fraction of the cost proposed by the vendor that maintains this generator.

Deer Run Pump Station Generator

Mrs. Biery reported that there was a problem with the Deer Run Pump Station generator that was initially diagnosed by Duquesne Light as a result of faulty wiring but was subsequently determined to be the result of the failure of three Duquesne Light transformers.
